



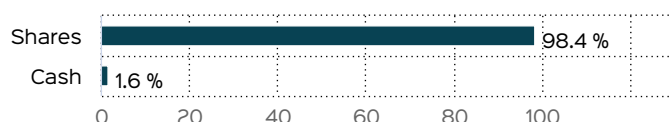

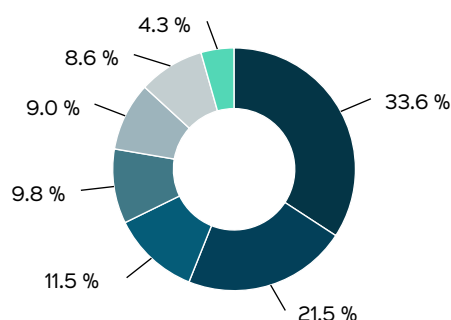
Fund portrait

Asset Allocation

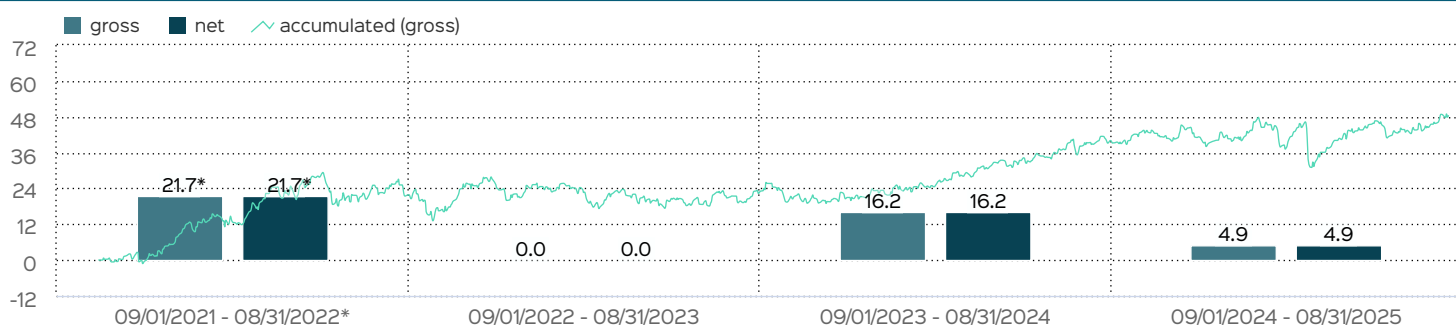

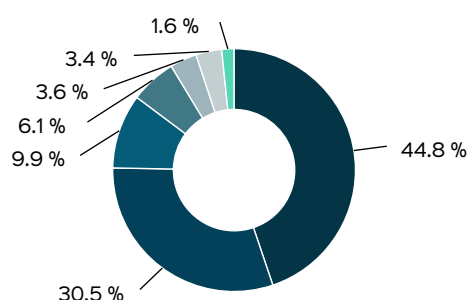

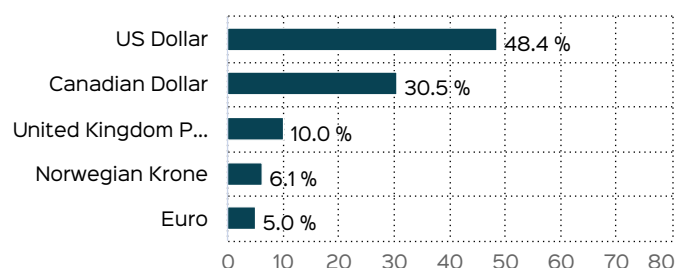
