

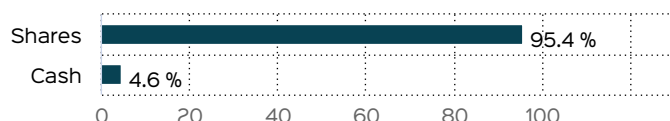

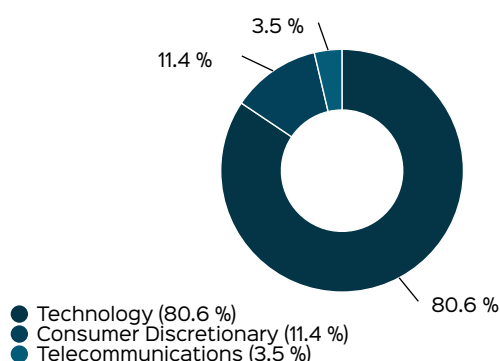
Fund portrait

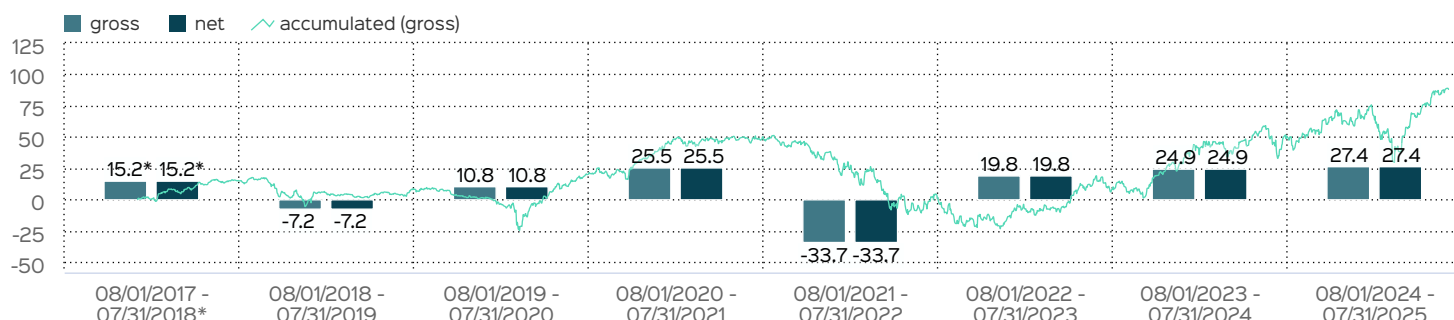
Asset Allocation

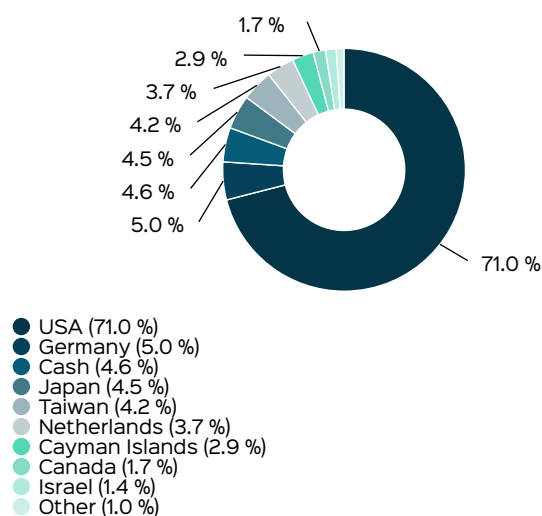

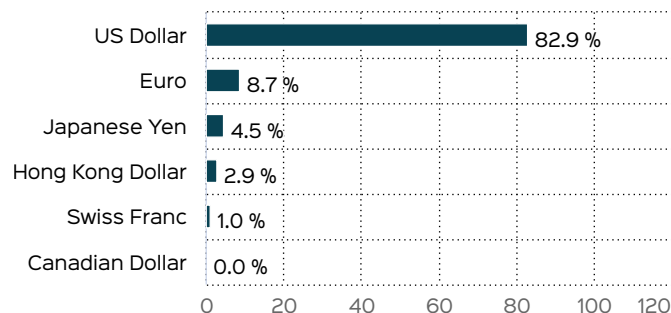
