


Fund portrait


Classification to SFDR





The performance fee is calculated as follows and reduces the positive performance of the investor. 15 % of the amount by which the share value at the end of a settlement period exceeds the share value at the beginning of the accounting period the development of the benchmark index (absolutely positive share value development), but in total up to a maximum of 10 % of the average value in the accounting period. A negative performance must be made up.
